

**ORDINANCE NO. 1495**

**AN ORDINANCE OF THE CITY OF DES MOINES, WASHINGTON** relating to business license registration fees and license expiration dates for mobile and stationary itinerant vendors, and amending DMMC 5.57.100 and DMMC 5.57.110.

**WHEREAS**, on June 3, 1999, the Des Moines Council enacted Ordinance No. 1239, establishing regulations for mobile and stationary itinerant vendors, and

**WHEREAS**, on October 21, 2010, the Des Moines City Council, pursuant to DMMC 5.04.030, adopted Resolution No. 1135 updating business license application fees, and

**WHEREAS**, DMMC 5.57.100 and .110 need to be consistent with the fees and license requirements set forth in Resolution No. 1135, and

**WHEREAS**, this ordinance is necessary to promote the public health, safety and welfare; now therefore,

**THE CITY COUNCIL OF THE CITY OF DES MOINES ORDAINS AS FOLLOWS:**

**Sec. 1.** DMMC 5.57.100 and section 11 of Ordinance No. 1239 are amended to read as follows:

**Fees.** Pursuant to DMMC 5.04.030, applications shall be submitted to the City Clerk on such forms as he or she may direct with the registration fee as set by resolution of the City Council. A separate application and license shall be required for each location of a Stationary or Mobile Itinerant Vendor.

**Sec. 2.** DMMC 5.57.110 and section 12 of Ordinance No. 1239 are amended to read as follows:

**Expiration of license.** A license issued under the provisions of this chapter shall expire at the end of the calendar year for which it was purchased.

**Sec. 3. Severability - Construction.**

(1) If a section, subsection, paragraph, sentence, clause, or phrase of this ordinance is declared unconstitutional or invalid for any reason by any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this ordinance.

(2) If the provisions of this ordinance are found to be inconsistent with other provisions of the Des Moines Municipal Code, this ordinance is deemed to control.


