

ORDINANCE NO. 1436

AN ORDINANCE OF THE CITY OF DES MOINES, WASHINGTON relating to the official posting locations for the City of Des Moines and amending DMMC 1.08.010 to replace the Redondo Store and Post Office location with the Redondo Boat Launch location as an official posting location to serve our southerly Des Moines residents.

WHEREAS, Ordinance No. 764 designates the official locations for the posting of notices, and

WHEREAS, Ordinance No. 1169 added the Redondo Community Store and Post Office as an official posting site to accommodate the southerly residents of the City, and

WHEREAS, the Redondo Community Store closed its doors to business in 2007, and the Post Office is scheduled to permanently close on September 5, 2008, leaving necessity for a new posting location for the convenience of Redondo area residents; now therefore,

THE CITY COUNCIL OF THE CITY OF DES MOINES ORDAINS AS FOLLOWS:

Sec. 1. DMMC 1.08.010 and section 1 of Ordinance No. 764 as amended by section 1 of Ordinance No. 1169 are amended to read as follows:

Designated. Whenever the City is required to post notices under the ordinances of the City or the laws of the state, they shall be posted at the following locations:

(1) The Des Moines City Service Center located at 21630 11th Avenue South;

(2) The Des Moines Marina Office located at 22307 Dock Avenue South;

(3) The Des Moines Library located at 21620 11th Avenue South; and

(4) The Redondo Boat Launch located at 28225 Redondo Beach Drive South.

Sec. 2. Severability - Construction.

(1) If a section, subsection, paragraph, sentence, clause, or phrase of this ordinance is declared unconstitutional or invalid for any reason by any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this ordinance.

(2) If the provisions of this ordinance are found to be inconsistent with other provisions of the Des Moines Municipal Code, this ordinance is deemed to control.
