How to Schedule Field Rentals:

Applications for field use in 2019 are accepted beginning January 1, 2019

- Submit an Application form with processing fee and non-refundable deposit to:

Field Rental Processing Fee:

Non-refundable Processing Fee: \$25 per application/event

Field Rental Deposits:

The non-refundable deposit is applied towards the organization's approved field & light use fees.

Tournament Deposit: \$600 for 1 day and \$1,000 for 2 days

League Game Deposit: \$100

Refunds:

- Refunds will be given for *non-tournament* field cancellations when requested with 10-business days advanced notice.
- Refunds for inclement weather or light failure for scheduled use must be requested within 3-business days or at the conclusion of the last scheduled field use, accounts will be adjusted to reflect any rainouts called by Des Moines and/or make-up games
- Tournament Refunds: Will only occur if the City of Des Moines staff determines fields are unplayable due to inclement weather or unsafe playing conditions.

Hold Harmless

The user shall defend, indemnify and hold the City of Des Moines, its officers, officials, employees, agents and volunteers harmless from any and all claims, suits, actions, or liabilities for injury or death of any person, or for loss of damage to property, which arises out of the use of Premise or from any activity, work or thing done, permitted, or suffered by User in or about the Premises, except only such injury or damage as shall have been occasioned by the sole negligence of the City. The User shall be responsible for any damage caused by User.

Field Use Liability Insurance

The Organization or Users must provide the City of Des Moines a Certificate of Liability Insurance covering their full period of use, from an insurance company licensed to conduct business in the State of Washington. The insurance company must provide a separate endorsement naming the City of Des Moines as a Primary-Non contributory additional insured with coverage limits no less than \$1,000,000 Commercial general liability per occurrence and \$2,000,000 Commercial general liability aggregate. The City shall be provided with written notice of any policy cancellation within two business days of receipt of such notice by the policy holder.

Field Lighting:

Athletic field lights will not remain on past 11pm.

Approved field users are responsible to obtain field status updates due to inclement weather and/or unplayable conditions by calling the Field Condition Line. Note: Des Moines Field Rain-out Line is updated *only* when fields are closed. When the field is closed the message will read: *This a ball field update for Day, Date. All fields are closed.*

Please Note: The closure refers only to the date stated in the message. If the message and date have not been changed, assume the field is playable.
